

## Terms and Conditions Governing the Citibank Singapore PremierMiles Cards - Kaligo Promotion

"Promotion" refers to the "Citibank Singapore PremierMiles Cards - Kaligo Promotion". "Citi Miles" refer to Citi Miles earned on the Citi PremierMiles Card account.

- 1. The qualifying period for this Promotion is from 1 January 2024 to 31 December 2024, midnight to midnight, both days inclusive ("Qualifying Period").
- 2. This Promotion is valid only for all Citi PremierMiles credit cards issued in Singapore.
- 3. Customers will earn 10 Citi Miles for every S\$1 spend with their Citi PremierMiles credit card(s) including supplementary cards for all qualifying charges made at Kaligo.

Qualifying Charges are charges made at Kaligo from any Citi PremierMiles Credit Card account (unless excluded by Citibank in its absolute discretion) which do not arise from any Equal Payment Plan purchases, refunded, disputed, unauthorized or fraudulent retail purchases, Quick Cash transactions, balance transfers, annual card membership fees, interest, goods and services taxes, late payment fees and any other form of service / miscellaneous fees.
