



Citi PremierMiles Card Online Sign-Up 2024 Flash Deal Promotion Terms and Conditions (“Promotion”)

1. Promotion and Gift

- a) The Promotion Period is open from 12 September 2024 to 31 October 2024 (both dates inclusive) (“Promotion Period”).
- b) If you meet all our requirements under the promotion, you will receive S\$100 Trip.com Gift Card (“Gift”).
- c) You will only be entitled to receive one (1) Gift subjected to additional terms as set out below.

2. Eligibility

- a) This Promotion is opened to new customers (as a main cardmember) who applied this Promotion during the Promotion Period.
- b) You are a new customer if
 - i. you do not have any existing Citi Credit Card (as a main cardmember) at the time of your application; and
 - ii. you do not previously own a Citi Credit Card (as a main cardmember) that was terminated/closed in the last twelve (12) months prior to your application; and
 - iii. you do not have any pending applications for Citi Credit Card (as a main cardmember)

3. Qualifying Criteria

- a) To qualify, your application for a Cit PremierMiles Card must be approved and successfully opened within 30 days from the date of application and meet the Qualifying Spend Criteria

Eligible Card	Qualifying Spend Criteria
Citi PremierMiles Card	S\$800 on retail transactions (by both main and supplementary card member) on any of your Eligible Card within 2 calendar months, from month of your account opened date. Example: if account is opened on 15 September, the Qualifying Spend Period will be from September to end of November.

- b) Qualifying Spend refers to any retail transactions (including internet purchases) which do not arise from (i) any Equal Payment Plan (EPP) purchases, (ii) refunded / disputed / unauthorized / fraudulent retail purchases, (iii) Quick Cash and other instalment loans, (iv) Citi PayLite / Citi FlexiBill / cash advance / quasi-cash transactions / balance transfers / annual card membership fees / interest / goods and services taxes, (v) bill payments made using the Eligible Card as a source of funds, (vi) late payment fees, (vii) any other form of service/miscellaneous fees and (viii) Citi PayAll transactions where the customer is not charged the Citi PayAll service fee. Any reversals/rebates/refunds, whether full or partial, will go towards reducing the accumulated retail transaction amount.
- c) If you no longer meet the Qualifying Spend within the Qualifying Spend Period due to transactions reversed / refunded / rejected, Citibank reserves the right to forfeit / clawback the Gift.
- d) The Qualifying Spend will be determined by “spend date” which is the transaction date based on Singapore Timing (UTC+08:00). Citibank bears no liability for any late submission or transaction posting of any purchase by any merchant that might affect the Promotion.

4. Fulfillment of the Gift

- a) The Gift will be awarded to the Eligible Cardmember within four (4) calendar months from the end of the Qualifying Period. Citibank may extend the date of fulfillment with notice. You will not be entitled the Gift for any of the following reasons:
 - i) any of your credit card(s) or any account(s) with Citibank is/are not in good standing (as determined by Citibank in its discretion and including default of any payment to Citibank) or is/are inactive / closed / terminated / suspended and/or not activated at any time during the Promotion Period or any time after the Promotion Period up to and including the time of fulfillment of the relevant Gift; or
 - ii) if Citibank is of the opinion that you had at any time: a) acted fraudulently or dishonestly; and/or b) conducted in bad faith or otherwise in an inappropriate manner to gain an unfair advantage against Citibank; or
 - iii) or any reason which Citibank determines in its discretion that you should not be entitled to receive the Gift, such discretion to be exercised reasonably.
- b) The Gift will be in the form of one gift card number of S\$100 which must be redeemed and activated with the provided PIN in the Trip.com App within 3 months from the date of when Citi uploads the gift card number and PIN on Citi Mobile® App. For clarity, 3 months refers to period in which the gift card number and PIN are uploaded on Citi Mobile® App (First Month), and three full calendar months immediately after the end of the First Month. Example: if the gift card number and PIN are uploaded on 15 January 2025, the redemption period will be from 15 January 2025 to 30 April 2025.
- c) You will need to link the Gift to your Trip.com account on the Trip.com app with the gift card number and PIN provided to utilize the Gift. More information on the detailed expiry date can be found on your Trip.com app upon linking of the Gift. The use of the Gift on Trip.com app is subject to the terms and conditions as may be imposed by Trip.com. Please refer to Trip.com's website, under Gift Cards for these terms and conditions.
- d) Push notification via Citi Mobile® App (or such other mode of communication as Citi may determine in its sole discretion) will be sent to eligible cardmembers who are awarded the Gift with the redemption details based on his/her contact details on Citi's record. The Gift is non-exchangeable and not redeemable for cash. Citibank will not be responsible for non-receipt of push notification. Any failure to redeem the Gift by the redemption period will lead to forfeiture of the Gift and no extensions will be entertained.
- e) The Gift will only be available on the Citi Mobile® App and you will be required to have access to their Citi Mobile® App and log in to retrieve the Gift.
