- 4. Please note that the above excluded Merchant Category Codes ("MCC") and the above excluded merchant list is not exhaustive and may be updated from time to time at any time at our discretion. Cardmembers are advised to check this list regularly for updates.
- 5. A Merchant Category Code ("MCC") is a four-digit number assigned to a merchant/business by the merchant's acquiring bank. The acquiring bank provides the credit card payment facilities used by the merchant and it determines and applies (with respect to the account), the MCC which in its view best describes the merchant activity. Citibank does not determine the merchant's MCC.
